# Minutes of a Parish Council Meeting held on

Thursday 7 December 2023 at 7.00 pm in the Dining Room at the Coach & Horses, Fenny Bentley

### 1. Welcome and apologies for absence

Cllr Miller welcomed everyone to the meeting, there were no apologies.

#### 2. **Declaration of Interests**

The Chair declared an interest as a relative of the Clerk.

### 3. Invited comments from County & District Councillors and members of the public

There were no County or District Councillors present at the meeting.

### 4. Approval of Minutes of meeting held on the 12 October 2023

The Council resolved to accept the minutes of the last meeting held on the 12 October 2023 as a true record of that meeting.

## Matters Arising from the last meeting

Overgrown Verges above the Bentley Brook have been reported to the County Council. Bulbs have been planted on the triangle below the Church.

### 6. Progress on the pedestrian bridge over the river adjacent to the A515

No further information regarding the bridge was currently available. The planning permission will now have lapsed. Clerk to update Cllr Spencer. Action: Clerk

#### 7. Highway matters - flooding/potholes/traffic/bridge

One large pothole on Ashes Lane needed to be reported, this had been repaired earlier in the year and a large pothole on the A515 below the bridge needed to be reported again as no action had been taken following previous reports. Action: Clerk

#### 8. Use of land between Fenny House Farm and Valley View, Fenny Bentley

Following the change of ownership of this field, a caravan and a storage container had been placed on the land. Several residents were concerned about this; it was understood that the owner planned to have chickens, goats and a cow on the field. After discussion the Council resolved that this should be reported to the Peak Park Planning as there was possibly unpermitted development and change of use.

### 9. Planning Application No. NP/DDD/0923/1110 - Woodcock Delph, Delph Cottage, Ashbourne Road, Fenny Bentley – demolition of shed and construction of a 2-bedroom bungalow.

The Council resolved to have no objection to this application. One resident had commented that they would like the property to have clear signage to avoid disruption to neighbours, this comment was to be passed to the Peak Park. Action: Clerk

## 10. Housing Needs Survey Report & Update

The next step was for Councillors and the Housing Officer to have a walk around the village to identify possible sites in the Village. This would be done in conjunction with Tissington Village. **Action: Clerk** 

## 11. Speed Indicator Device Update following installation

The speed indicator device had been installed and residents had noticed that traffic appeared to be slowing down as result. It was hoped that data from the signs would be downloaded in due course. **Action: Clir Croft**
