# Minutes of a Parish Council Meeting held on Tuesday 27 October 2022 at 7.00 pm in Fenny Bentley Church

### 1. Welcome and apologies for absence

Cllr Miller welcomed everyone to the meeting.

### 2. Declaration of Interests

The Chair declared an interest as a relative of the Clerk.

### 3. Invited comments from County & District Councillors and members of the public

There were no members of the public, County or District Councillors present at this meeting.

# 4. Approval of Minutes of meeting held on the 19 July 2022

The Council resolved to accept the minutes of the last meeting held on the 19 July 2022 as a true record of that meeting.

#### Matters Arising from the last meeting

The hedge along the footpath from Ashes Lane to the School had now been cut back and trees also pruned.

Footbridge over the river – negotiations regarding the land were ongoing.

Overgrown hedge at Hinkley Fields – the Clerk read out an email received from the owner regarding the overgrown hedge. Clerk to respond and clarify the situation regarding the cutting of hedges which were obstructing the highway.

Tidying up of the area around the shed – this work is still outstanding. Action: Clerk

### 6. Highway matters – flooding/potholes/traffic/bridge

Councillors were concerned about the general condition of the road surface of the A515 through the village, particularly areas near the Coach & Horses and on the hill toward the Bentley Corner. Clerk to photograph and report. *Action: Clerk*

The Fenny Bentley Initiative (FBI) had been reinstated and the first event would be held in church on the 2 December.

The Chair had attended a Benefice meeting, there was some interest in re-establishing a Parochial Church Council (PCC) for Fenny Bentley. The advertisement for a new vicar had been published. Cllr Stone confirmed that he would like to be on the PCC. There was a church service planned for the 30 October at 10.30 am this would be led by Rev Arthur Champion.

There had been no action by the Peak Park on the static caravan, but it was understood that the Peak Park had a large backlog of issues that needed to be actioned and there were problems with staffing.
